**FINAL AWARD**

The Project Director, National Highway Authority of India, 5/7 Trikuta Nagar, Jammu vide his letter No.PD/JMU/11012/LA/DC-Jammu/9479 dated 25-11-2009 has placed a revised indent and requested that fresh proceedings for the acquisition of land required for widening of National Highway in District, Jammu after excluding the Forest land be initiated.

In pursuance of the aforesaid indent Tehsildar, Jammu was directed to furnish the revenue documents in triplicate of village Majeen after deleting the forest land. The Tehsildar, Jammu submitted revenue documents for 04 Kanals 01 Marla of land.

Accordingly, Notification under section 4 (I) of the Land Acquisition Act Svt, 1990 was issued vide this Collectorate No.DCJ/LA/ACR/NHAI/Majeen/2009-10/709-16 dated 14-01-2010 and objections from the land owners/interested persons were invited within 15 days from the date of issue of the Notification.

The Tehsildar, Jammu after services of the notice returned the same to this office vide his No.5674/OQ dated 08-03-2010. No land owner/interested person filed objection within prescribed period.

Thereafter case was submitted to the Deputy Commissioner, Jammu vide this office letter No.DCJ/LA/ACR/NHAI/Majeen/2009-10/925-26 dated 12-03-2010 with the request that compensation of land involved in the instant acquisition would be less than Rs.1.00 crore (Rupees One crore only) which is within the pecuniary jurisdiction of Deputy Commissioner concerned to issue declaration under section 6 & 7 of the Land Acquisition Act Svt, 1990 amended vide SRO's 235 & 236 of 2009.

The Deputy Commissioner, Jammu after due consideration of the case issued Notification under section 6 & 7 of the Land Acquisition Act Svt, 1990 for 04 Kls 01 Marla of land situated at village Majeen vide Notification No.28/DCJ of 2009-10 issued under endorsement No.DCJ/LA/ACR/NHAI/Majeen/2009-10/996-1000 dated 20-03-2010 whereby it has been declared that subject land is required for public purpose i.e. widening of National Highway in village Majeen, Tehsil and District, Jammu.

In pursuance to the directions issued by the Deputy Commissioner, Jammu notification under section 9 & 9-A of the Land Acquisition Act Svt, 1990 was issued vide this Collectorate No.DCJ/LA/ACR/NHAI/Rangoora/2009-10/1052-56 dated 30-03-2010 whereby all the concerned land owners/interested persons were called upon to attend the office of undersigned within 15 days from

the date of issue of Notification in respect of measurement of land to state the nature of their claims for compensation.

The case was further submitted to the Deputy Commissioner, Jammu vide this office letter No.DCJ/LA/ACR/Majeen/Draft-Award/2010-11/84 dated 29-04-2010 for approval of rates in the instant acquisition.

As intimated by the Deputy Commissioner, Jammu the case was placed before the Committee of Collectors in their meeting held on 01-06-2010. The Committee after deliberations observed that the rate proposed in the Draft Award is fair and justifiable for adoption in this case.

Finally, the Committee approved the rate of Rs.2.50 lacs (Rupees Two lacs and fifty thousand only) per kanal irrespective of land classification and conveyed the same to this office by the Deputy Commissioner, Jammu vide his letter No.DCJ/LHS/NHAI/AoR/JMU/Majeen-146/92 dated 16-06-2010.

Accordingly, the rate of Rs.2.50 lacs per kanal irrespective of land classification is adopted in the final award as under:-




Under the standing instructions it is further certified:-

03. That no payment has been made in respect of land under acquisition.
04. That no payment shall be made if the land escheats/escheated to the state under the Agrarian Reforms.
05. That payment of compensation shall be made keeping in view of guidelines issued by the Administrative Department under LB-10 of 1980 and Agrarian Reforms Act, 1976.
